

## Bari Malik Shabazz

At *Terrible Truth*, Martha Trowbridge speculates<sup>1</sup> that Obama's date of birth was not August 4, 1961, as he claims, but October 28, 1959. She further suggests that he was born not in Hawaii, but in New York City—with the name Bâri' M. Shabazz. Bâri' means "of Allah." M. is for Malik or Malachi, meaning King. Shabazz is the name taken by civil rights leader Malcolm "X" (who was born Malcolm Little). "X" used the names Malachi Shabazz, Malcolm Shabazz, and Malik El-Shabazz.

Why would Obama have been given that name if he was the son of Stanley Ann Dunham and Barack Hussein Obama, Sr.? *Because he may in fact have been the son of Stanley Ann Dunham and Malcolm "X."* Trowbridge points out that Bâri' M. Shabazz was assigned Social Security Number 084-54-5926 in New York in 1974. She further notes that, according to the Social Security Death Index (SSDI), Bâri' M. Shabazz died in August 1994. But "He didn't really die," suggests Trowbridge. "His birth identity 'had' to die. ... What with his prodigious [political] plans, 'Barack Obama' certainly couldn't risk having Bâri' M. Shabazz walking around, now, could he?!"

The SSDI shows that the death was not based on a death certificate but a report by a family member or "or someone acting on behalf of a family member." The records also reflect the code "PE," which means "*an inconsistency exists between what was reported and what was recorded in the government's files.*"

Interestingly, one of the addresses Trowbridge found for the name Bâri' M. Shabazz was a mere block away from the 1959 address of Malcolm X in East Elmhurst, New York.

Ms. Trowbridge lists no sources for her information, but there are more than a few reasons not to dismiss her theory out of hand. As readers of *The Obama Timeline* know, Malcolm X visited Kenya in 1959 and met with Tom Mboya. Mboya was a prominent politician and the Secretary General of the Kenya Federation of Labour—and a close friend of Obama, Sr. (Further, Mboya visited the United States in 1959 to obtain financial support for the American education of Kenyan students.) It is not unreasonable to believe

that Malcolm X met Obama, Sr. in Kenya during his visit. (Mboya was murdered in 1969. Obama, Sr. testified against the killer. That led to Obama, Sr.'s first car accident, a hit-and-run meant to kill him but which instead resulted in the amputation of his legs.)

Keep in mind that Obama's mother, Stanley Ann Dunham did not want to attend the University of Hawaii and wanted instead to go to the University of Washington, where many of her high school chums were headed. If "X" fathered Obama with Dunham, and "X" already knew that Obama, Sr. was in (or headed to) Honolulu, one can imagine "X" persuading Dunham to go there for the purpose of "obtaining a black father" for their child. ("X" could certainly not have let it be known that he fathered a child with a white woman—not when "X" split with the Nation of Islam partly over the issue of the illegitimate children of its leader, Elijah Muhammed.)

So, "X" needed a cover for his child, and also wanted to look after him—his only son—from a safe distance. He persuaded Obama, Sr. to be the temporary father, and gave him some cash as an added incentive. Dunham perhaps had the baby in New York City, or even Vancouver—where she would obtain free Canadian health care, be asked fewer questions, and then head to Seattle to attend the University of Washington with her high school friends. Stanley Ann likely received some cash from 'X' as well. Grandma Madelyn Dunham registered the infant's birth in Honolulu as an at-home delivery. Everybody won... except that Stanley was stuck with an infant. So she made her way back to Honolulu and dumped the kid on her parents, while she continued her studies of anything and everything non-American.

"X" asked his closest comrades to look after junior should anything happen to him. That included his personal attorney, Percy Sutton, and Black Panther attorney and revolutionary Donald Warden (who would later take the name Khalid al Mansour). When junior needed cash for school, it came from FOX ("Friends of X"). When junior needed to get into Harvard, he got a letter of recommendation from Percy Sutton—and Harvard got cash from Saudi Prince Waleed bin Talal to fund a Muslim studies program. Why did bin Talal pony up the cash? Because Warden/al Mansour was his financial advisor. (Warden also previously holed up at a San Francisco marina with terrorists William Ayers and Bernardine Dohrn—future buddies of Obama—while they hid from the FBI and plotted a revolutionary overthrow of the United States.)

Those who have been paying attention may have noticed that Obama's older daughter is the spitting image of one of the daughters of Malcolm "X." Of course, Obama himself

resembles “X” for more than he resembles Obama, Sr. or Frank Marshall Davis. Obama also shares some facial resemblance to his maternal grandfather, Stanley Ann Dunham. Obama, Sr. had a deep voice like James Earl Jones, but junior (Obama) has no such voice. Compare videos of “X” speaking and Obama speaking and try to argue there are no similarities.

Obama also often voices the “sssss” sound much like “X” did. (Listen to Obama say “Congresssss” in his “pass this jobs bill now!” speech to a Joint Session of Congress. It can clearly be heard in his very first words: “Mr. Speaker, Mr. Vice President, Members of Congresssss...” “X” had that same speech impediment. <sup>2</sup>

Obama’s daughter Malia Ann may have been named in honor of one of the daughters of Malcolm “X,” Malika Shabazz, or after Malcolm “X” himself, whose tombstone is inscribed with “Hajj Malik.” Malik means “king” in Arabic, while Malikah means “queen.” (Malcolm “X,” who was born Malcolm Little, became a Sunni Muslim and after a pilgrimage to Mecca he called himself El-Hajj Malik El-Shabazz; his children use the surname Shabazz.)

Many readers may also recall Obama’s victory speech at Chicago’s Grant Park on election night. Obama wore a black suit with a red tie. His youngest daughter, Natasha, wore a black dress; older daughter Malia wore a red dress; and Michelle Obama wore an arguably unattractive red and black dress that appeared to represent a large “X.” The

stark colors and the “X” suggest that the outfits are meant to honor Malcolm X. Red is the traditional color of socialism, and is associated with social democrat and socialist political parties; black is the traditional color of anarchism, and black power. *Who the Hell puts their little girl in a jet black dress for a celebratory occasion?* Where does one even buy a black dress for a little girl?

Coincidences and speculation prove nothing, of course, yet circumstantial evidence is often enough to get you jailed for murder (Scott Peterson), or not (O.J. Simpson).

Is Barry Obama Soetoro really Bâri’ M. Shabazz? I am certainly not about to dismiss that theory. From my perspective, O’s father was very likely Malcolm “X.” Whether his original birth certificate says Barry Little, Bari Shabazz, Barry Dunham, or Barack Obama I have no way of knowing. But that document—whether it lies in Honolulu, New York, Vancouver, or Kenya—certainly says *something* he wants kept secret.

For my money, the little girl in the black dress says it all...

*Note: One problem with the Bâri' M. Shabazz theory is that it is inconsistent with the statement of a woman who claimed she had to show Stanley Ann Dunham how to change a diaper—when she visited her with her newborn baby in August 1961. If Obama was born in October 1959 his mother would certainly not have needed help with that task almost two years later. On the other hand, it may be that the visit was not in August 1961, and a 1959 birth date could explain why Obama appears “big for his age” in some school photographs. The earlier birth date could explain a photograph of his bikini-clad mother purportedly taken on a Honolulu beach in July 1961—clearly showing that she was not pregnant.*

*Every Obama incident must, of course, be taken with more than a few grains of salt. One cannot exclude theory X for being inconsistent with theory Y unless one is certain that theory Y is fact and not just another theory or unsupported claim. The simple truth is that no one knows much of anything about Obama with any degree of certainty, except that he was born somewhere, sometime.*

*Ms. Trowbridge has also uncovered a photograph from the April 1962 edition of “Muhammed Speaks,” the Nation of Islam newspaper now known as “Muslim Journal.” The photograph is captioned, “The Young Listened,” and accompanies an article that states, “More than 12,000 people on February 23 gathered in Chicago’s International Amphitheater to hear Messenger Elijah Muhammad speak on The Future Of The American So-called Negroes.” The photograph shows a black infant or toddler with a woman who could be white and could be his mother. Trowbridge speculates that the photograph shows a young Obama with Stanley Ann Dunham.*<sup>3</sup>

*On November 5 ThePostEmail.com reports that a reader has requested Form SS-5 for Bâri' Malik Shabazz. Form SS-5 is completed by a person applying for a Social Security number. Because Bâri' Malik Shabazz was reported deceased, Form SS-5 can be obtained via a Freedom of Information Act request. But The Post & Email has also been “provided with information stating that ‘public records’ pertaining to Bari M. Shabazz have been altered to show that he is still alive and living in East Elmhurst, NY, rather than dead, as recently reported in Trowbridge’s post.” If the individual is alive, his Form SS-5 cannot be obtained. (The unstated assumptions are that Bâri' Malik Shabazz is Obama; Bâri' Malik Shabazz was declared dead in 1994 to get rid of that identity as*

*Obama prepared for his entry into politics; and Bâri' Malik Shabazz has now been miraculously declared undead in order to prevent anyone from viewing his records.)*

*On November 7 attorney Mario Apuzzo (Kerchner v. Obama) provides evidence of a March 1982 automobile accident involving Bari Shabazz, who is ticketed for driving without a license. Shabazz fails to show up in court and provide his drivers license—which is supposedly from New York. Apuzzo speculates that the driver may be the same Bari Shabazz who Trowbridge believes is actually Obama.*<sup>5</sup>
