27 **Plaintiff Alleges:**

28 I, Shreepriya Gopalan, the Plaintiff have the following complaint against Barack  
29 Obama who, according to the Media has been elected to the United States Presidency in  
30 November 2008:

- 12 and news channels such as CNN, NBC, FOX News, TV channels in their entirety, Radio
- 13 Channels, Newspapers, Bill Boards have gone berserk with information and lives that do
- 14 not exist.
- 15 6. All of the above have only been magically I Chinged and are a figment of my imagination.
- 16 As stated in the other pleading letter attached with this one, my invention, the I Ching
- 17 created the world and the American Presidency along with other Presidencies,
- 18 Governments and Government Agencies. None of these exist with the people and the
- 19 policies/resources that are otherwise claimed to exist by the Media.
- 20 7. The term Government was coined by me and its policies, guidelines, rules, agencies such
- 21 as the FBI, the CIA were all a figment of my imagination that accidentally went over
- 22 through the metaphysical layer created by my thoughts.
- 23 8. I I Chinged the world safe and secure. I I Chinged the secret service, the Police
- 24 Departments and other Security features such as Alarms and even the Seat Belt.

26 **II. Plaintiff claims damage incurred due to Misrepresentation, Loss of Intellectual**

- 30 9. **Rachel Ray** the fictitious hostess of 30-minute meals on Cable TVs Food Network is an
- 31 image on Television that only broadcasts all my recipes and ideas for culinary shows. She

1 amongst others on the Food Network and the Food Network itself must be sued for  
2 perjury and stealing ideas from me.

3 10. **Britney Spears** another I I Chinged Music Idol does not exist. The Music industry was I  
4 Chinged by me. I have I Chinged most of the songs that are in the stores using my mind  
5 and by singing some of them myself.

7 **III. Plaintiff sues the USCIS on account of Fraud, Delay in Processing an Immigration**  
8 **case, Financial and Emotional Distress incurred, Loss of mobility and feeling of**  
9 **entrapment due to unduly delay and fraud.**  
10

11 11. I, Shreepriya Gopalan announce that I have studied, lived and worked in this country this  
12 1999 August.

13 12. I have always lived in this country legally.

14 13. I arrived in the USA in July 1999 with an F1 Visa. After the completion of my graduation  
15 with a Masters in Computer Science from the University of Akron, I worked on an EAD.  
16 I then obtained an H1 B visa and worked as an IT professional until April 2005 when I  
17 applied for the Labor process as part of the Green Card application Process.

18 14. After having received approval for Labor, I applied and was approved for I-140 in 2007. I  
19 then applied for the I-485 in July of 2007. It has taken about 2 years for the I-484 to be  
20 approved. The EAD I received for Employment is valid until 2010.

21 15. I have undergone undue stress and feelings of immobility and entrapment because of the  
22 undue restrictions that the Green Card filing imposes on immigrants such as myself. The  
23 H1 Visa transfer restrictions as well as the Green Card filing process as well as the  
24 restrictions that go along with it have resulted in my having to move from state to state in  
25 order to keep my status valid and active. I have moved 7 states/cities up to this point.

26 16. I am told that in the current processing stage, it is unknown how long it will take for the  
27 case to be approved and for me to get the permanent resident status or Green Card.

28 17. There has been a lot of money spent on Attorney fees and appointments and case filing.  
29 There has been a lot of time spent waiting for case approvals.

30 18. I am also aware that the USCIS is an I chinged agency and does not really exist in its  
31 entirety. There are only a handful of agents that are available when needed.  
32

1 19. I request the court to shut down USCIS and grant me the Permanent Resident Status as  
2 well as Citizenship status in accordance with the information I have already reported  
3 regarding I Ching, the Presidency and myself and the undue need for me to apply for  
4 permanent residency when I can as well be a Citizen in possession of the Businesses I  
5 own, my true Identity, the Presidency and all the money that truly belongs to me.

6 20. I have gone through a great amount of depression having to think that I am the only one  
7 to have ever applied for the Green Card in this manner (through the USCIS).

8 21. It is a shame that the United States is carrying on with so much fraud being committed to  
9 one person.

10 22. All Fraud and Crime has not been exposed due to I Ching.

11 23. I sue the USCIS and claim damages in the amount of 10 million USDs. Damages  
12 incurred include Punitive, Distress, Depression, Financial and Emotional Distress

13 24. I also request the court as in other Complaints I have filed, that the I Ching gadgets are
