Dear Dr. Taitz:

The Council of Conservative Citizens and the Defend Our Freedoms Foundation evidently share the same goals.

We at the East Oakland chapter have been following your case for several years, and we agree that we have the wrong president; he's ineligible and should be brought to justice. I look forward to assisting DOFF as we mutually work towards a purified United States of America.

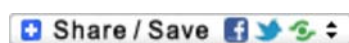

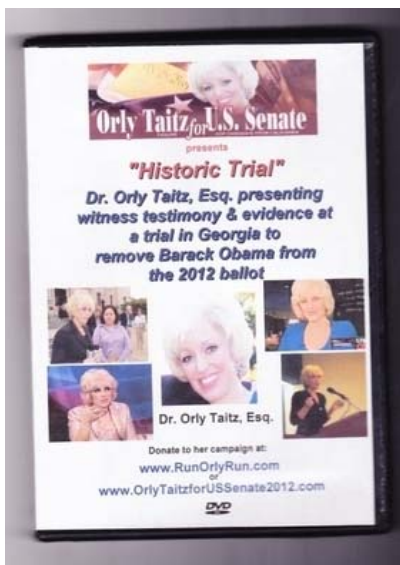
