### **Un-Sealed Affidavit of Douglas Vogt**

Douglas Vogt is invoking 28 U.S.C. §1746, states that the matters stated herein are true under penalty of perjury:

- This affidavit will cover five main individuals who came to our attention (Paul Irey and myself) over the past two years. The affidavit will present the evidence I have developed by examining forged Certificate of Live Birth (COLB) forms given to Dr. Jerome Corsi and Detective Mike Zullo of the Sheriffs office in Mariposa County Arizona who sent Paul and me copies of them to examine. The COLBs came from two individuals. One whose name is Miki Booth who lived in Hawaii but now lives in Oklahoma, approached Jerome Corsi directly to get into his confidence and gave him two of her families long form birth certificates. One had problems indicating forgery both had their certificate numbers off by 25 days.
- The second person is Johanna Ah'nee who is a personal friend of Miki Booth when they both lived in Hawaii. I believe Johanna Ah'nee is the forger of the Obama COLB as well as other birth certificates created to cover-up the first mistake the principles made and that being the certificate number assigned to Barack Obama was out of sequence if it was registered with the Hawaiian Department of Health (HDOH) on August 8, 1961. I have already proved that in my open affidavit. I will also show that Johanna most likely knew Barack Obama II when they were both kids in Hawaii.
- The third person of interest Kevin Davidson who we believe did the research for the principles in the conspiracy. This name may only be a pseudonym. He goes by the pen name of Dr. Conspiracy on his web page (obamaconspiracy.org).

- The fourth person is Dr. Alvin Onaka, Registrar of the Hawaiian Department of Health His registrar's stamp appears on all the forgeries we have received including the short for COLBs that we have acquired via the internet or by e-mail. He had to have known about the forged registrar stamps from the news and from a letter I wrote him.
- The fifth person is Loretta Fuddy, the Director of the Hawaiian Department of Health I was an accountant and I did an income analysis from her public disclosure statement. The analysis shows that her salary alone does not explain the amount she paid down on her mortgage during 2011.

### Who did the Obama administration fear the most back in 2010

The reporter and investigator the Obama administration feared the most was Dr. Jerome Corsi. He had written a biography on the Democratic Presidential candidate John Kerry in 2004 called *Unfit for Command: Swift Boat Veterans Speak Out Against John Kerry*. That book was credited for damaging John Kerry's chances of winning the presidential election. The next book he wrote was about Senator Barack Obama in 2008 called *The Obama Nation: Leftist Politics and the Cult of Personality*. Both books were best sellers. The leftist in the Obama administration knew by mid 2010 that Dr. Corsi was researching another book on Obama. That book was entitled *Where's the Birth Certificate?* Its publication date was May of 2011 and it is most likely the main reason the Obama administration had to produce some kind of birth certificate so as to negate any disclosures that Dr. Corsi may make. They also coordinated the release of the forged birth certificate on Wednesday just before Navy Seal Team 6 went into Pakistan and killed Osama Ben Laden on Friday night: That way if anyone found problems of forgery with the PDF or the reporters copy, that news would be buried by the supposedly bigger story of the killing of Ben Laden—it worked. Now since I have established who the administration feared the most let us start the sequence of events.

#### Miki Booth and her spying and delivering two forged or altered COLBs.

World Net Daily (WND) is an internet newspaper that Dr. Corsi writes for. They were very active in reporting the findings of various researchers on Obama's birth certificate as well as other subjects. He even wrote several articles about Paul's and my research. WND sponsored a cruise going to the Eastern Caribbean for 7-days which sailed on September 19, 2010. They called the cruise *Tea Party at Sea* and WND had invited many conservative speakers to give lectures during the seven-day cruise. The publisher, owner and contributing writer is Joseph Farah and he was one of the speakers on the cruise. Another speaker was Dr. Jerome Corsi, one of their chief writers for WND. There was an Oklahor a Tea Party activist, Miki Booth who was formally from Hawaii, who went on the cruise with her husband to specifically meet Dr. Corsi so she could give him a packet she had prepared only for him. To quote from her book *Memoirs of a Community Organizer from Hawaii*, 2011:

"When I met Dr. Corsi, I handed him my binder containing copies of every Hawai'i birth certificate owned by members of the Booth family and research we'd done. We were thrilled to learn that he would have a new book out in early 2011 titled *Where's the Birth Certificate?* The title supports WorldNet-Daily's billboard campaign asking what millions of Americans want to know. Fred told Dr. Corsi to keep the binder and use anything he wanted from it." (pg. 58)

So what Dr. Corsi eventually did was give those copies to Paul and me to examine. My first interest was to get as many birth certificates that I could test for the accuracy of the certificate number and prove how it was arrived at. If enough of them were acquired it would prove whether Mr. Obama's certificate was out of sequence or not. I will be referring to Table 1 now so you can see what was discovered. In my open affidavit (p.10, Table 2,) I displayed 15 good COLBs that fit the legal explanation of when and how the certificate numbers are produced. Table 1 in this affidavit shows the birth certificates that were presented and out of sequence and do not follow the description in the Federal or State laws. The two COLBs Mrs. Booth gave Jerome

Corsi I have labeled Booth1 is for her husband Fredric Booth and Booth2 is for their son. Both are 25 days more than what they should be when calculated based on the average number of births per day up to the State Registrar acceptance and filing date. That was a red flag to me be cause I knew the principals in the forgery had to cover up their first mistake by producing COLBs with wrong certificate numbers for the purpose of throwing off investigators as to the importance of the sequential numbering.




Figure 1. The certificate number on Boo 11 showing two different type fonts for the certificate number.

With further examination I also found that the certificate number on Booth1 was not produced by a normal Bates numbering machine. In my research we acquired six Bates numbering machines of that period. We were able to purchase machines with 6, 7, 8, and 11 numbers of wheels. I had never heard or found a 4 wheel Bates machine and why would the Department of Health have one anyway with over 14,500 births in 1949? It just did not make any sense. Figure 1 shows the Certificate number on Booth1 on the lower half. You can clearly see there are two different typefaces and two different baselines so that has to mean that two separate Bates machines created Booth1 COLB but that is not possible at the Department of Health. We know they used an eight wheel numbering machine.





Figure 2. The numbers are overlapping and they should not be.

When I looked closer at the certificate number I noticed that the 8 and 2 looked too close. The numbers are on metal wheals that cannot touch or overlap. The proper Bates number spacing is 10.8 points and the grids displayed are set to that width. The top half of the Figure 1 shows the same number produced by our Bates numbering machine and what it should have looked like. There is normally about one point of space between the numbers. It looked like the 8 was not fully formed on the lower right because of bad ink coverage so I found and tried a number 8 from 1959, 1961 and 1964 year birth certificates that had an 8 in the number. I overlaid each one on the Booth1 8 and all three showed that the 2 was overlapping the 8. Figure 2 is an enlargement of the original 82. As you can see the bottom left of the 2 is over the line. Figure 3 shows

the overlaid 8 from the 1964 COLB which makes it clearer that the 8 and 2 are overlapping. This is a point of forgery and is the same mistake the forger did on her COLB as you will see later. It appears the forger took numbers from other COLBs and pasted this number up but got the number spacing slightly wrong.



- Figure 3. The number 8 from a 1964 Hawaiian COLB overlaid over the 8 on the Booth1 COLB. It appears the 8 and the 2 are overlapping which impossible on a Bates numbering machine.
- These two problems with the certificate number on Booth1 causes me to strongly believe that this certificate number is forged besides the number is also 25 days out of sequence.
- This is only the beginning of the problems with this birth certificate. I have already explained the workings of a manual typewriter in the open affidavit. I am not printing private information of the Booth's COLBs because she published the Booth1 birth certificate in her book on pages 192. I saw some of the same problems I saw on the Obama Certificate namely irregular line spacing and word spacing. Figure 4 shows the top three lines with the six point grid. I lined up the grid using the lower case letters in Honolulu because I noticed that the "H" was bent to the left throughout the certificate, which is Ok. You can have bent type arms but all the letters on that arm will be bent to the left or right—they weren't. The line length of this 1949 form was 512 points or 7.15-inches. I was able to get the typewriter type on the first three lines to fit the 6-

point grid across the entire line. The leading was another story. I put the base line on the "Honolulu" in box 1 and the "Honolulu" below in box 1b was also on the baseline. Box 1c starts out correct but then starts to drop below the baseline a little. The right side of the form is a different story. In box 2a the "T.H." is on the baseline but the "Honolulu" is 2 point above it for no reason especially since the form line drops down half a point. In box 2c "Honolulu is 3 points below the baseline as well as the address in box 2d.

On Figure 5 we see even worst line spacing problems. I set the grid to His first name in box 3a and the entire line sat on the baseline. You see the type fit the grid vertically also except for a few exceptions which I will cover in the section on letter spacing. The second third and fourth lines are all off the grid. Form box 4 the word "Male" is one point below the baseline. By box 6 the date is 2 points below the baseline. In boxes 7 and 8 the entire line is 1 point below the baseline. The text in boxes 9 and 10 are 2.5 points below the baseline.

The Figure 6 shows the last four lines of type. The baseline was set on the name "VR-GINIA." The next line box 14 and 15 with the age and city are one point below the baseline. The next line box 17 is on the baseline and the last line box 18c is one point below the baseline. The time of birth of 8:00 and the address "881" both do not fit within the grid for some reason. The Left-hand margins are inconsistent. The inconsistent line spacing is an indication of forgery because a manual typewriter will only measure out 12, 24 or 36 point line spacing unless the typist releases the platen and manually moves the carriage down line by line, but there would be no reason for them to do that.

#### Word Spacing problems




Figure 7. Words or number that did not fit the grid.

The Booth1 COLB was better than the Obama COLB in respects to the word spacing but it was not devoid of some glairing problems. Figure 7 shows the few words or numbers that did not fit the six-point grid. All are points of forgery.

- In Boxes 2 and 10 the initials "T.H." did not fit the grid and were always too far to the left as well as the periods which should have been centered. The rest of the capital "T"s in the document were centered in the grid so there was no explanation why these two would not be. In box 12c the word "WHITE" was also too far to the left even though the other two words on the line both before and after it fit inside the grids. In the box that tells the time of birth the "8:00" was too far to the right even though the "a" in the same box was perfectly in the grid. In box 18c the "88" were spaced too far to the right even thought the rest of the letters in the box were centered in the grid. All of there would indicate the birth certificate was put together letter by letter and not put down by a typewriter.
- One of the problems showing the word spacing problem is the form was distorted for some reason. You will notice on Exhibit 1 that the left hand vertical line tilts 1.5 points to the left space of the line length varies over 2.5 points from the top line length to the bottom third of the form. This is why I displayed sections of the form only and set the grid to the lines on the left hand edge of that section. The only reasons we can explain this is if the copier the Booths used to copy this COLB had a distortion in it or the forger never squared off the form before placing the letters and words on the form.



I found capital letters such as the "H", "C" and "V" were too far to the left in the grid but the "B" and the "H" are too far to the left the forger pasted the "TH" below the baseline. the lower case of those letters were not (Figure 8). Since both upper and lower case letters are on 21 ter fit perfectly in the grid. I also found multiple letter spacing for the capital letters "C," "V" and "BO." Of the four examples of the "C" shown in Figure 8, number one and two are too far to the left but examples three and four are centered. For the Capital "V" number one and three are about the same but number two centered. The "B" and "O" are also inconsistent. I centered the words on the Capital "B" for examples one, two and three and when I did that the "O" was too far to the right except for example two. In example four I centered the "o" and the capital "B" was too far to the left.





Figure 10. Inconsistent placement of periods.




Figure 11. The Alvin Onaka stamp with a script "E" under the "A".

More recently, I served for two years on the National Association for Public Information Statistics and Information Systems (NAPHSIS) Fraud Prevention Committee, and participated in numerous conference calls on fraud prevention, and attended national presentations on vital records fraud and identity theft. I've looked over the shoulders of vital records staffers as they process births. 


Figure 17. The damaged A with a script E under it.




Figure 19. Same registrar stamp used 41 days before Obama's stamp.




Figure 20. The same registrar's stamp used April 13, 2011 only 14 days before Obama's COLB but to spell out her entire last name. In essence she was signing her great work.




Figure 23. Variations in letter pairs. Figure 24. Additional two letter combinations that do not match 58

Johanna was not even consistent pasting up her own name and we have two different letters exhibited here also (Figure 26). The first "A" is wider than the second. The first "H" is slanted to the right at the second one is straight. The last "E" is larger than the first. The letter spacing is random at best.

### Word Spacing and line spacing on the Johanna COLB

In order to check the word spacing on Johanna's COLB I had to first straighten out the typewriter lines because the first line (form box 1a) was tilted .35-degrees counter clockwise. After I corrected for that I aligned the 6 point grid to the first line of type, which was her name as seen in Figure 27. The problem was that all the lines below there were a point or more below the

baseline. The word spacing was generally OK except line 2 and the first part of the "Kapiolani" but the rest of the line fit the grid.

You can see from the first six lines of the form that when the six point grid was set in first line we immediately have a problem. Starting on line 2 the word "Female" and "Kapolin form box 6c further to the right. In box 5a the August is 2 points below the baseline though "Female" was almost on the baseline. The rest of the lines are at least one point below baseline. You will notice that generally the letters vertically line up on the grid using the first of type.

I had set my grid to the left hand margin. By the time we get to form boxes 10 to 17 (Figure 28) the type starts to shift to the left 1 point. This was because the forger did not square off the form she got before she started putting the type down. The distortion becomes more evident at the bottom of the form. Exhibits 4 and 5 show the COLB with a squared grid set to the right side of the form:

Shown in Figure 29 is when I adjusted the baseline of the type to the second form line, the date in box 5a, then the lines fell on the two pical grid up until the last line, form box 14, where the distortion was the greatest and it was one point below the baseline. The words on the right side were still one point farther to the left than they should have been. It was obvious that the form was forged because of so many word and line spacing problems with her COLB:




Figure 32. Repeated words with the same exact letter spacing.


A typed form will only have one typeface from one typewriter. If you find more than one typeface for the same letter on the same form, you have a forgery. Just like Obama's COLB we found multiple typefaces for the same letter on Johanna's. Figure 34 shows some letters were the same ones found on Obama's COLB which ties the forger to both forgeries.

It is well established in typewriter forensics that no two typewriters are exactly the same because the long arms of the type bars that hold the letters are easily bent. Bending would frequently happen when a fast typist would get two keys stuck together before they hit the paper. 


Figure 36. Two different "H"s on the same birth certificate.

#### A Matter of Style




Figure 40. The last letter "H" in HEALTH looks more like an "A".

The registrar stamp (Figure 39) also had a problem with it. If you look closely the first line has greater line spacing between the first and second line. The line spacing between the second line and the third line is more like what we have seen from legitimate COLBs. Also there should not be such a type density difference between the first line and the rest of the text. Finally the last "H" in HEALTH on the third line should not look like that. Figure 40 shows a close-up of the word and you can see the "H" looks like a "A" and that is impossible with a metal embossing stamp and I would go as far as to state that it would be impossible for a rubber stamp. What we may be looking at is something that is akin to the forgers "signature." The "TXE" on

Obama's COLB and now a "HEALTA" on this one. The last thing we found wrong with the registrar stamp was that the first line of type is one point further left than the other lines. How Johanna Ah'nee could have known Barack H. Obama II in Hawaii.

Principals in this forgery case could not exactly advertise for a skilled forger to create world's greatest forgery. So the question we had was: Why was Johanna chosen to do the forger and why pick her? Johanna Ah'nee works at a graphics store in Hawaii and when Mike interviewed her in Hawaii he told me that she was a graphic artist also. She was born the sementh as Barack Obama in 1961 and when Obama came back to the United State when he about nine years old he could have been enrolled in the same schools as Johanna. But that is

really enough to place them together until I read the obituary of her father James Kaohu Ah'nee who died in October 2012. It said he was a member of the Marine Firemen's Union for 51 years and employed with Matson Navigation for 44 years. That was one of the three unions that struck the docks of Hawaii first in 1949 and later in 1962 also they are the same Unions that the Communist Frank Marshal Davis wrote for the Honolulu International Longshoremen's & Warehousemen's Union (ILWU) newspaper. He was the philosophical leader of the dock worker unions in Hawaii. Frank Marshal Davis also had been watched by the FBI because of his Communist activities because he was a card caring member of the Communist Party USA.

We know from Barack Obama's own book that his grandfather Stanly Dunham took him over to Davis's house two or three times a week to spend some quality time together so Obama would have a father figure in his life and bond with someone of his own race. It is possible that Johanna's father might have also gone over to Davis' house to talk over union business and Johanna might have gone with him and met Barack Obama that way. It is also very common for unions to have family picnics and other get-togethers. Obama and Johanna could have met during one of those events. I have proven that Johanna was not a very good forger so there had to be another reason she was chosen. The only one I can conclude is that they personally knew each other when Obama lived in Hawaii. That also means Barack Obama had to be the one who chose Johanna to be the forger because he was the only one among the principals who could have known her.

#### The Registrar Alvin Onaka and plausible deniability

Alvin Onaka's forged Registrar stamp has shown up on short forms and long forms, all with some error(s) incorporated in it. He was aware of many of these forgeries because I wrote him a certified letter restricted delivery on July 28, 2012 (Exhibit 8) sending him examples of his stamp on provable forgeries and asking him to verify which stamps were genuine and which

were forgeries. I never received back a response. The letter was also copied to the FBI in Wee ington D.C., the Special Agent in charge in Hawaii, the U.S. Attorney in Honolulu and Min Zullo of the Arizona Sheriffs office. I have shown these registrar stamps in the open affidavital this sealed one and all with state file numbers out of sequence. Some of these birth certificates have personally examined and felt the round State DOH seal on it which seemed genuine. Inc. tioned earlier that if a forger was making a good forgery they would just copy an original rep-

trar stamp and not make any changes to it. So when you discover so many altered region

stamps, and each one alters in a different way, you have to come to the conclusion that they a

being altered to give plausible deniability to the Registrar. Figure 42 to 48 show these altered




Figure 41. Genuine Registrar stamp acquired October 2011

First I will show a registrar stamp that is genuine. Figure 41 is the one on Virginia Sur hara's short form birth certificate acquired in October 2011 by her brother Duncan.




Figure 43. Enlargement of the distorted area.

I will start with Johanna's sons' COLB (Figure 42) that was supposedly given to Johanna on March 11, 2011 by the Department of Health, just 41 days before Barack Obama got his COLB. Remember that supposedly no one was allowed to get the long form birth certificate since 2001 but Johanna had no problem getting the COLB for her son and without suing the Denartment of Health or being President of the United States. This again proves a special relationship between Alvin Onaka and Johanna Ah'nee because by State Statute the registrar has the sole discretion as to who gets a copy of the COLB. There was nothing wrong with his COLB including the certificate number. The only place that had an image of the COLB was the Hawaiian DOH. I was able to inspect the COLB when I was in Arizona and the round embossed DOH seal looked and felt genuine and the date stamp was also embossed like it should be. I will assume Johanna got the image of the COLB from the DOH and had it sealed and dated. When I looked closer at the registrar's stamp it was also forged. The area in the box has enlarged type that you can clearly see on the third line of text. Shown in Figure 43 is an enlargement of the errors. I copied the word "THE" from the beginning of the third line and moved it to the end. As you can see there is a size difference of one point. There is also a type density difference on that line that should not happen. Also visible again is a one point type size difference between the first "S" in State to the last "R" in Registrar. None of these errors can happen with a metal embossed stamp or even a self inking or rubber stamp. No professional stamping house would make mistakes like these. In fact the only way you can have gradually increasing type size is using Adobe Photoshop which again prove the forgeries were created using Photoshop. In this case the DOH gave her the son's COLB and she must have inserted the registrar's stamp later.

The next registrar stamp is the one that appeared on Mr. Obama's short form in lar 2008 (Figure 44). It has three problems. The first is the inconsistent ink density on the start This should not show up on a metal embossed stamp or even a self inking stamp. The second glaring problem is the baseline of the "State Registrar" line runs uphill but the three previous lines are level. Finally again we see a size difference from the first letter to the last letter of State Register's line.




Figure 45. Johanna Ah'nee's Registrar's stamp from her COLB dated August 8, 1995.

- The next Registrar's stamp is found on Johanna Ah'nee's own COLB supposedly acquired on August 8, 1995. There are five problems with this stamp. 1. Inconsistent ink density on the stamp. 2. Lines two and three are not flush left and they should be. 3. Inconsistent word spacing on all three lines. I measured only the first line but it is obvious the problem is throughout. Since all three lines are flush left the letter spacing should all be exactly the same. 4. The last "H" on line three was altered to look like an "A." She might have done this because "AH" are the first two letters of her last name. 5. Inconsistent line spacing between line one and line two. The only thing I can say is that she didn't change the size of the letters on the "State Registrar" line. These errors would never appear on a legitimate Registrar's stamp.
- The next registrar's stamp is on Miki Booth's Son's COLB. The certificate number was off by 25 days as the others. Figure 46 shows the same problems that I found on Johanna's registrar's stamp (Figure 45). The problems were the same but still different. The inconsistent letter spacing is obvious along with the font size differences on line three. The line spacing is different between the three lines and the "State Registrar" line has two different type sizes. One of the things that is different is that the last "H' in Health is not damaged to look like an "A."
- What is important about these errors and the two registrar stamps is that it is another direct link between Johanna, the forger, and Miki Booth.




Figure 47. Enlargement of Figure 45.

The end of the was one point higher than the beginning. All three lines must have the same consistent leading The same problem with the "State Registrar" line is present on Obama's stamp. The type at the same problem with the "State Registrar" line is present on Obama's stamp. end of the line is larger than the beginning of the line. You can clearly see in Figures 45 and the problem does not exist and it is supposed to be the same registrar's stamp. The same density problems appear as well as the damaged "THE" in the second line. He could always say that it was not his registrar's stamp and he didn't certify the birth certificate. The forger and the Registrar have a working relationship.

#### Certificate Numbers out of sequence

I had found seven certificate numbers out of sequence including Barack Obama's. Some were on short form birth certificates that came directly from the DOH. I ask that any investigative body check if the names and numbers match up on the CDC Department of Vital Statistics or if necessary check with the original microfilm copy that was sent to the CDC and see if the numbers match up with the names listed below. If they do not then you will immediately know that a forgery ring is operating in the Hawaiian Department of Health. If you find that Obama's number 10641 really belongs to Virginia Sunahara you will immediately know the Presidents Birth Certificate is a forgery and that he is not a US citizen. You will also know, that someone in the DOH gave Obama the Bertificate trimber of a dead Bary who was born on August 4, 1961 and died the next day. The only person(s) who would know that is an employee of the Hawaiian DOH who had access rights to the database and also computer rights to enter and change the data his come of the same found on the previous change. After we received a copy of the Tepper document, mentioned in the open affidavit, And Onaka certified the PDF copy he attached to his letter as being genuine and that it represent what was in their records. The problem was that the Tepper document was altered to covere the white halo made by unsharp mask. Figure 49 shows a portion of the Tepper COLB to show they altered the document. What they did was add green to the entire document makes even the type and the form lines green just so they could cover-up the whit halo. The settle how they did it is in my open affidavit. That alteration could only mean that either he or some else at the Department of Health had contact with the forger so the forger could change the green color globally to hide the white halo. Since Onaka signed the letter with a rubber stamp and the someone initialed it, we can assume he knew about the letter and its contents. For these reason personally do not see how he could avoid not being considered a principal in this forgery at treason case.

# Loretta Fuddy, Directory of the Hawaiian Department of Health.

Loretta Fuddy was first appointed acting Director of the Hawaiian Department of Hell towards the end of January 2011. She is the first non-medical doctor ever appointed by the waiian Governor as director of the Department of Health. She became the Director in February The reason why the Governor fired his first appointee, who was a MD, for someone who was a psychologist, is something the grand Jury should look into. What made me suspicious

Ms. Fuddy is understanding the story the Obama White House said how they received the two birth certificates, which was sending a high priced lawyer, Judith Crowley, from Seattle Washington to Honolulu Hawaii and then to Washington D.C.. This must have cost well over \$7,000 for last minute airfare and her hourly billing fee. The cost for the two COLBs was only \$14.00. They could have paid by wire transfer and the DOH would have received the money that day for a wire transfer fee of \$10.00 (est.). UPS would have delivered the two COLBs the next day by 8:30 a.m. for less than \$100.00. As an accountant the only reason I-could think of for her trip to Hawaii was to deliver cash to pay for the forgeries and pay off all those directly involved. The reason they would want to hand deliver the money was so there was no financial trail where the money came from and where it went:

With this in mind I got a copy of Loretta Fuddy's 2011 and 2012 Disclosure of Financial Interests forms. Table 2 show an estimated of her income and expenses to come up with an application of funds. It shows that there is an income shortfall of no less than \$50,000 between her disposable income of an estimated \$28,000, before other living expenses, and the \$78,000 reduction in her liabilities by the end of 2011. It looks like she was paid a bribe.
